依據「個人資料保護法」（以下簡稱個資法），請詳細閱讀大漢學校財團法人大漢技術學院（以下簡稱本校）依個資法第8條及第9條規定所為以下「考生之個人資料蒐集、處理及利用告知事項」。

In accordance with the Articles 8 and 9 of the "Personal Data Protection Act" (hereinafter referred to as the Personal Information Law), please read in details the following "Collection, Handling, Utilization and Notifications of Personal Information of Examinee" by Dahan Institute of Technology (hereinafter referred to as the School).

一、組織名稱/大漢學校財團法人大漢技術學院。

I. Name of the institution : Dahan Institute of Technology.

二、個人資料蒐集之目的：

本校蒐集您個人資料的目的在於辦理入學考試相關之試務、提供成績、招生、分發、證明、日後報名及相關統計使用及其他完成考生入學考試必要工作或經考生同意之目的，且當錄取時轉入學生學籍資料。

II. Purpose of personal data collection:

The purpose of collecting your personal data is to handle the works related to the entrance examination, provide the results, student enrolment, affiliation assignment, certification, registration and related statistical data analysis, and also other specific purposes those with the consent of the examinee. The personal data shall be transferred into student registration one after enrollment.

三、個人資料之蒐集方式：

透過考生網路報名或書面遞交而取得考生個人資料。

- The personal data mentioned above includes name, ID number, ARC number passport number, date of birth, photo, gender, education background, emergency contact, physical address, email address, phone number, family profile, bank account number, and low-income household proof.

五、個人資料處理及利用：

(一)個人資料利用之期間：

考生個人資料及相關試務（含成績）資料，除法令或中央事業主管機關另有規定外，以上開蒐集目的完成所需之期間為利用期間。

(二)個人資料利用之地區：

臺灣地區（包括澎湖、金門及馬祖等地區）或經考生授權處理、利用之地區。

(三)個人資料利用之對象：

除本校外，尚包括本於完成上開蒐集目的之相關合作單位，包含教育部或其他學術研究機構等。

(四)個人資料利用之方式：

入學考試期間之試務作業、考試成績與相關資訊之發送通知，提供作為試務、錄取、分發、報到、查驗等作業，考生（或法定代理人）之聯絡，基於試務公信的必要揭露與學術研究及其他有助上開蒐集目的完成之必要方式。

V. Scope of Use of Collected Personal Data.

(1) Time period:

Applicant's Personal Data, including examination score, is to be used only for the data collecting period and stated purposes, unless otherwise regulated by the government authorities.

(2) Regions where personal data is used:

Geographic areas affected Taiwan, including Penghu, Kinmen and Matsu or other areas authorized by examinees.

(3) Objects of personal data utilization:

The School and the institutes which sharing the information such as the Ministry of Education, and other academic research institutes.

(4) Usage of personal data:

The personal data shall be used for works related to entrance examination including admission, registration, enrolment, affiliation assignment, information for contact etc. The data shall also be used for academic researches and necessary information disclosure based on public trust.

六、考生如未提供真實且正確完整之個人資料，將導致無法進行考試報名、緊急事件無法聯繫、考試成績無法送達等等，影響考生考試、後續試務與接受考試服務之權益。

VI. Incorrect personal data will lead to the incomplete of registration, incapability of emergency notification, or failing to receive test results. For enrolled students, incomplete data could jeopardize student's legal rights in entrance exam at the School.

七、考生應確認提供之個人資料，均為真實且正確；如有不實或需變更者，應即檢附相關證明文件送交招生事務暨華語中心辦理更正。

VII. Each examinee is responsible for the accuracy of all personal data provided. Should correction or update be needed, proof of authentication is required when submitting to the Admissions Affairs and Chinese Language Center.

八、本校得依法令規定或主管機關或司法機關依法所為之要求，將個人資料或相關資料提供予相關主管機關。

VIII. Upon request from government administrations or authorities, the School will release student information as requested.

九、個人資料之權利及權益：您依法得行使個人資料保護法第3條之查閱、更正個資等權利，但因法令另有規定者，本校得拒絕之。權利之行使方式請洽本校招生事務暨華語中心。若因您行使上述權利，而導致權益受損時，本校將不負相關賠償責任。

IX. Examinee has the rights towards his/her own personal data, and he/she may exercise these rights to review and amend according to Article Three of the Personal Information Law. However, the School reserves the rights to deny such request if it interferes with DIT's school operation; details of the way how to exercise such request can be obtained through DIT's Admissions Affairs and Chinese Language Center; DIT bears no responsibility to any possible damages occurred to the examinee's rights as a consequence from such request.

一、申請資格 / Qualifications

1. 具外國國籍且未曾具有中華民國國籍，於申請時並不具僑生資格者，得依本簡章規定申請入學（不含港澳生）。

具外國國籍且符合下列規定，於申請時並已連續居留海外（不含大陸、香港及澳門）6年以上者，亦得依本簡章規定申請入學：

- (1) 申請時兼具中華民國國籍者，應自始未曾在臺設有戶籍。
- (2) 申請前曾兼具中華民國國籍，於申請時已不具中華民國國籍者，應自內政部許可喪失中華民國國籍之日起至申請時已滿八年。
- (3) 前二款均未曾以僑生身分在臺就學，且未於當學年度接受海外聯合招生委員會分發者。依教育合作協議，由外國政府、機構或學校遴薦來臺就學之外國國民，其自始未曾在臺設有戶籍者，經主管教育行政機關核准，得不受前二項規定之限制。
- (4) 第二項所定六年、八年，以擬入學當學期起始日期（二月一日或八月一日）為終日計算之。
- (5) 第二項所稱海外，指大陸地區、香港及澳門以外之國家或地區；所稱連續居留，指外國學生每曆年在國內停留期間未逾一百二十日。連續居留海外採計期間之起迄年度非屬完整曆年者，以各該年度之採計期間內在國內停留期間未逾一百二十日予以認定。
- (6) 具外國國籍並兼具中華民國國籍，且於「外國學生來臺就學辦法」中華民國一百年二月一日修正施行前已提出申請喪失中華民國國籍者，得依原規定申請入學，不受第二項規定之限制。

Foreign students who are neither citizens of the Republic of China (R.O.C.), nor Overseas Chinese may apply for admission according to the regulations of this brochure. These regulations are not applicable for those who are citizens of PRC, Hong Kong or Macao. Foreign students who had stayed abroad (Mainland China, Hong Kong, and Macao are excluded) for more than 6 years and meet the following requirements may also apply for admission according to the regulations of this brochure.

- (1) While applying, foreign students currently having the nationality of R.O.C. must have not ever established household registration in Taiwan.
- (2) An individual who waived R.O.C. citizenship at least 8 years, and no longer has R.O.C. nationality at the time of application shall present an annulled status proof by the Ministry of the Interior.
- (3) Applicants in the preceding subparagraph (1) and subparagraph (2) had NEVER studied in Taiwan as Overseas Chinese Students, also did NOT assign for admission by the “University Entrance Committee for Overseas Chinese Students” (<http://www.overseas.ncnu.edu.tw/>) for the academic year.

According to the Education Cooperation Framework Agreement, a foreign student who was selected by a foreign government, organization, or school, and does not hold a Taiwan household registration from the time of his or her birth is not subject to the limitations as prescribed in the preceding 2 paragraphs after receiving the approval from the authorized educational government administrations.

- (4) The six- and eight-year calculation period as prescribed in Paragraph 2 shall be calculated from the starting date of the semester (February 1st or August 1st) as the designated due date for the time of study.
- (5) The term “overseas” as prescribed in Paragraph 2 is limited to countries or regions other than Mainland China, Hong Kong and Macau; the term “reside overseas continuously” means that an individual may stay in Taiwan for no more than a total of 120 days per calendar year. If the calculated calendar year is not one complete calendar year, their stay in Taiwan should not exceed 120 days within the calculated calendar year period.

(6) An individual, who has both foreign and R.O.C. nationalities and has applied for an annulment of their R.O.C. nationality before February 1, 2011, will not be subject to the limitation as prescribed in Paragraph 2.

2. 外國學生具有國外高中畢業學歷且具備相當中國語文聽、講、讀、寫能力者，得申請入學本校四年制學士學位班；具有大學學士學位或具有與我國學制相當之同等學力資格者，得申請入學本校研究所碩士學位班。依教育部規定：外國學生以英制高中中學五年學歷(Form-5)申請入學者，應於原課程外加修至少12個學分方得畢業(即加修約4~6門課程)，其增加學分數與修習科目由各所、系(科)訂定。Prerequisites for applications for the four-year college programs include a senior high school diploma and sufficient proficiency in the four skills-listening, speaking, reading and writing in Chinese. Applicants who possess bachelor's degree are eligible to apply to study in a master's program. According to the regulations of the Ministry of Education, foreign applicants holding a Form-5 certificate obtained from high schools of British system must earn at least 12 credits in addition to those of their original courses (i.e., additional 4-6 courses), in order to be eligible for graduation. The additional credits and courses shall be determined by each department.

3. 課程主要以中文授課為主，申請人需具備良好的中文語言能力。申請人須具備華語文聽、說、讀、寫能力，華語以「華語文能力測驗」(TOCFL)成績2級以上能力證明為準。
The medium of instruction and examination is in Chinese; applicants are advised to acquire basic Chinese language proficiency. Applicant should be proficient in Chinese, For Chinese proficiency, an applicant should provide a TOCFL certificate for Level 2 or above.

4. 本校學制自8月1日至翌年7月31日止，第一學期約每年9月中旬開始，第二學期約翌年2月中旬開始。
The academic year begins on August 1 and ends on July 31 in the following year. The first semester usually begins in mid-September, and the second semester begins in mid-February of the next year.

5. 修業年限 (Study Duration)：

(1) 大學部：四年制學士學位班：四至六年。

Four-year Bachelor's degree program: 4 ~ 6 years.

(2) 研究所：碩士班：二至四年。

Master's degree program：2 ~ 4 years.

6. 已在臺就讀其他大專校院之外籍學生，得比照本簡章申請入學本校，惟須另行檢附該大專校院之在學證明及歷年成績單。

Foreign students currently enrolled in other universities in Taiwan may apply for the admission of the School according to this brochure with the certificate of enrollment and official transcripts provided by original schools.

二、申請日期：2023 年 5 月 22 日~2023 年 7 月 10 日 / Application Date：May 22, 2023 ~ July 10, 2023

報名費：新台幣1,000元，所有銀行匯款手續費須由匯款人自行負擔。申請費一經繳交，恕不退還。

Application fee: NT\$1,000 (if paid in Taiwan). Applicants are responsible for any fee coming with remittance. And the application fee is non-refundable once paid.

Copy of the highest academic diploma and the transcripts of the highest educational degree officially sealed by original school. (If the original document is not in English or Chinese, the document must be notarized after being translated into English or Chinese.) Once those documents are dubious, the School may request them to be authenticated by R.O.C. overseas institutions, representative, consulates, or other mission authorized by the Taiwan Ministry of Foreign Affairs.

2.錄取方式/Admission method

總成績相同時，依資料審查、口試、資料審查之工作經驗及專業表現成績之次序，成績較高者優先錄取則依簡章所列之同分參酌比較分數高低決定之。備取生之遞補原則與正取生相同。

If the total scores are the same, those with higher scores in the work experience and professional performance in the data review and oral examination will be given priority. The principle of supplementary admission for candidates on the waiting list is the same as that of officially admitted.

※Students who are absent or have zero marks in any subject will not be admitted.

3.獎學金/Scholarships

大學部學生1位學雜費全免，期限4年；研究所學生1位學雜費全免，期限2年。但是每學期的學習成績必須符合學校的規定，否則取銷領取獎學金資格，不得異議。

One undergraduate student is free of tuition and miscellaneous fees, valid for four years; One graduate student

is free of tuition and miscellaneous fees, valid for four years. However, the academic performance of the awarded students in each semester must meet the school's regulations. Otherwise, the scholarship will be disqualified without objection.

- 4.同時申請一個以上系所者，僅能選擇其中一系所報到註冊。

Those applicants who apply for more than one program can only register into one of them.

- 5.報名時繳交之「畢業證書」及「歷年成績單」，除海外臺灣學校所發者外，應依教育部「大學辦理國外學歷採認辦法」規定辦理。

The diploma or degree and transcript submitted for application review shall first be authenticated in accordance with the R.O.C. Ministry of Education, except for diplomas and transcripts issued by overseas Taiwanese schools.

International students will be withdrawn from the Dahan Institute of Technology if their identities of international students have been lapsed by establishing household registrations, moving-in registrations, naturalizing or regaining R.O.C citizenships.
